- 3.1 General Manager Mr. Richard Yamasaki reviewed the Proposed Budget for FY2008-2009 created on a month to month basis (average of entire year)
 - a. Member suggested to show a comparison of past year/months with proposed budget

 - b. Concern for immediate installation of fire alarm, smoke alarm, and hook up to Alert alarm , possibility of sprinkler system, too, for the future.
 - c. Concern for cost of repairing cut wires on biometric machine discovered on morning of Nov. 17, 2008
 - d. September, 2008 Budget Report and General ledger will be shared at the next mtg.
 - e. 2 Errors on Hawaiiana Management Company letter: "each quarter" instead of "each month,"Date payment due should have been 12/31/08, instead of 12/1/08
 - f. Concerns about 2008's expenditures suggests need for internal control
 (1) 2007 Christmas parties: \$9500 for food, gift certificates, and gifts from Ala Moana Center.
 - (2) Use of 9 cell phones among staff
 - (3) Expenditures from Keiki Club (Committee member), does not appear to be self-sustainable. To be discussed further when the state of NECA's financial position is clarified and stabilized; when Keiki Club's

revenues and expenses are defined.
