### Hawaiiana Management Begins NECA Contract



On January 14, 2009, NECA President Donald Devaney, General Manager Richard Yamasaki, and members of the Budget and Finance Committee met with Phyllis Okada-Kacher and Ed Robinson of Hawaiiana Management at the company's main office. Ms. Okada-Kacher and Mr. Robinson provided the group with specific information about NECA's one year contract with Hawaiiana that began on December 1, 2008. Hawaiiana Management now provides a variety of monthly financial reports for NECA and has started an electronic bill payment service (SurePay) for quarterly assessments. Hawaiiana will provide an annual report to the Board and recommend a budget for the next fiscal year. The company will also organize the annual meeting of the Association and prepare and deliver notices of the meeting and proxy forms.

PRESIDENT'S MESSAGE

been called to active duty again to serve in Kuwait as a member of the Hawai'i National Guard. Mark has worked exceptionally hard on behalf of all his constituents, especially those of us in Newtown, concerning the traffic and transportation issues we are facing. He came to the January board meeting and explained that Ka'ahele is in for another re-striping facelift that will improve traffic flow and safety. He estimates that the project will be completed by the end of the year. Honolulu City Council member Gary Okino also sent a letter to the community announcing the efforts being made to repave Ka'ahele. We shall keep an eve on these issues and at the same time pray that Mark's tour of duty goes by swiftly and he returns safely home to Hawai'i.

Our board continues to make impressive progress in executing its responsibilities. Especially commendable has been the community volunteer participation on our various committees. Volunteer contributions are extremely valuable and much needed. We have many professional residents, such as attorneys, architects, certified public accountants, school administrators, business leaders, and tradesmen donating their time and expertise, resulting in improved business processes and accountability that are easy to understand and monitor.

Some of the board met with the leadership at Hawaiiana Management at their corporate headquarters in Honolulu to go over in detail the contract we have entered into with them for our financial management. I am more confident than ever before that the financial reporting will be timely and easy for all of us to read and understand. Our goal is to have a financial report in your hands prior to the annual meeting as is done by so many of the other property management firms in Hawai'i.

We are in negotiations with Alphabetland, whose five-year lease with NECA expired on 28 February 2009. The contract had an automatic six-month extension, so the board believes we will have a new contract shortly.

The Budget and Finance Committee has done an awesome job reconciling accounts and completing overdue audits and submitting a timely budget. Following are some general objectives and conclusions of our financial position: We are a microcosm of our national situation. We are spending more money than we are bringing in or just breaking even. The past four years have been deficit years, and as the national government uses Social Security money to camouflage the red ink, so do we with our "reserve account." A healthy reserve account should increase about \$100,000 per year. Instead, we have been withdrawing funds. Our total reserve account is just over \$1,000,000 and in today's economy, that is not enough for a community of our size. The easy solution is to

raise the assessment, but that is not the right solution. This board has pledged not to raise the assessment. We need to reorganize, look at how we spend money, and start making cuts. With the experienced personnel we have working as volunteers I am confident that we can streamline the Recreation Center operation at a reduced cost and add to our reserve fund. This year we have a goal of adding \$20,000. That means walking the walk. No installation parties, elaborate Christmas parties, or other waste. It will add up sooner than later. I am asking NECA residents to be vocal in their support of cutting costs and not increasing the assessment.

The Board wishes to thank Bill and Marion Coste for their leadership on the Communications Committee. Communication with you, the resident, is improving all the time and the Newtown Reporter has taken on a new look, which reflects their talent, energy, and hard work.

Aloha from the staff at the Newtown Recreation Center. We have been making good progress. While there is still much to be done, I would like to bring everyone up to date

on some items that are being worked on.

1. Roof problems: MRC Roofing was hired to repair some of the bad roof leaks, which are causing a lot of problems and are potential safety issues. We are looking into re-roofing the entire complex in the future as the present roof system is deteriorating.

2. Good news for the basketball players. The basketball court, which is heavily used every day, is scheduled to be upgraded. New backboards, rims, and safety pads have been ordered. Under consideration are the costs vs. benefits of resurfacing the playing court area and the relative importance of such a project compared to other maintenance needs.

3. The pool deck storage room doors and frames, which are severely rusted, will be removed and replaced. It will take approximately six to eight weeks for the new doors to arrive and be installed.

4. The Board will be reviewing proposals to improve our fire/smoke and security alarm system at the Recreation Center.

On another note, I have been asked to comment on problems with dogs here at Newtown. Complaints range from dogs running loose to dog poop in the yards, on the sidewalk strips of residents, and in our public parks. Dog owners, please keep you dogs secure and if you walk your dog, remember to bring a bag to pick up any poop.

#### From the Community Association Institute www.caionline.org



CAI developed the Community Association Fundamentals to foster a better conceptual understanding of how associations function and the roles of residents and association leaders.

We hope this primer will help the Newtown Estate Community Association's residents and volunteers recognize the core principles at the heart of the community association model and, even more importantly, inspire effective, enlightened leadership and responsible, engaged citizenship.

1. Associations ensure that the collective rights and interests of homeowners are respected and preserved.

2. Associations are the most local form of representative democracy, with leaders elected by their neighbors to govern in the best interest of all residents.

3. Associations provide services and amenities to residents, protect property values, and meet the established expectations of homeowners.

4. Associations succeed when they cultivate a

5. Association homeowners have the right to elect their community leaders and to use the democratic process to determine the policies that will protect their investments.

6. Association homeowners choose where to live and accept a contractual responsibility to abide by established policies and meet their financial obligations to the association.

7. Association leaders protect the community's financial health by using established management practices and sound business principles.

8. Association leaders have a legal and ethical obligation to adhere to the association's governing documents and abide by all applicable laws.

9. Association leaders seek an effective balance between the preferences of individual residents and the collective rights of homeowners.

10. Association leaders and residents should be reasonable, flexible and open to the possibility-and benefits-of compromise.

### **Bulky Item (Opala) Pickup**

Monthly opala pickup for Newtown is scheduled for the fourth Monday of each month and conducted over a three to four day period. All items must be placed at the curb by 6:00 a.m. on the first day of the pickup window.

Mayor Mufi Hannemann has made regular monthly bulky item pickup a priority for all the island. The benefits of

regular bulky item pickup are huge for NECA. Our streets and sidewalks can be clutter-free and safe, and we believe this will significantly reduce illegal dumping. It will only work if we all do our part to adhere to the schedule and place items at the curb only on designated days.

There's no excuse to dump on Hawaii. Collection services are readily available. Our garbage is collected curbside twice weekly, green waste twice monthly, bulky items monthly, and drop-off centers are available around the island. Please take the time to know the schedules and dispose of items properly. This is our home, our community, our island, and our responsibility is to care for its health and beauty.

The City of Honolulu provides for free collection of bulky items such as furniture, appliances, and mattresses. Most appliances are recycled. If your items are still in good, useable condition, contact organizations such as Goodwill and Salvation Army first.

#### **Rules for Bulky Item Pickup**

To help the city provide efficient service and to keep Newtown safe and attractive, you must follow these rules:

• Put items out for collection no earlier than the evening before your scheduled pickup day or period. Bulky items sitting at the curbside for long periods are unattractive, can be unsafe (especially for children), and can attract illegal dumping at that site.

• Remove or secure doors of refrigerators. Children have been known to suffocate in refrigerators, unable to open the doors from the inside. Remove the doors, tie the refrigerator closed, or place the door against the ground or a wall to prevent it from opening

· Do not block sidewalks, driveways or roadways.

#### Questions and Answers about Bulky **Item Pickup**

#### Whose bulky items will be collected?

All households except those in dwellings owned by the State or Federal governments.

#### What will be collected as bulky items?

Furniture, mattresses, bed frames and box springs, rolled up and fastened carpeting, appliances, minor home repairs/remodeling materials not to exceed one cubic yard.

#### What will not be collected as bulky items?

Construction materials, demolition debris, dirt, rock, concrete, large automobile parts and any refuse suitable for regular twice-a-week collection.

#### What if I can't wait for my scheduled collection period?

If the schedule is not convenient for you, you are welcome to drop off your bulky items any of the city's Convenience Centers. There are 9 locations open seven days a week.

#### What if I miss the collection crew?

Your bulky items must be stored on your property (not at curbside) until the next month's scheduled collection.

For those wanting to give away an item for free, the Honolulu Star-Bulletin offers a free "Recycler Ad' in the classified section. They will list the item for five days. Please call 529-4800 for details.

## **BOARD & COMMITTEE REPORTS**

#### **Architectural Committee**

Reminder: ANY EXTERIOR CHANGES (including landscaping, door replacement, window replacement, and solar units) requires an approval and permit from the NECA Architectural Committee. The Architectural Committee meets on the third Wednesday of each month. All Architectural Applications need to be received by the SUNDAY before the meeting. Please remember to attach the \$25 architectural fee to the application.

Please refer to our pre-approved paint swatches and roofing materials, available at the Newtown Recreation Center, when repainting and/or re-roofing your residence.

#### **Budget and Finance Committee**

On December 30 2008, the Budget and Finance Committee approved the revised Accounting Policy for Expenditures and Authorizations for 2008-2009, and forwarded it for Board approval. Mr. Richard Yamasaki presented three proposals for repair and replacements of the sink counter and cabinets in the multipurpose room (party/rec room). The Committee approved Doctor Cabinet to do the work, subject to Board approval. A meeting with Alphabetland preschool's owners, Mrs. Arizala and her son Kyle, was scheduled to review the lease agreement with NECA, which expires this year.

General ledgers and budget reports for September, October, and November will be presented to the committee at the next meeting for review and approval. Residents reported they have been pleased with Hawaiiana's Surepay system for paying quarterly assessments. The Treasurer's report was approved by the committee and forwarded for Board Approval.

#### **Communications Committee**

Our apologies to the homeowners for the inordinate delay in getting the NECA web site up and running. In the last issue of the Newtown Reporter, we targeted January 15th as an online date. We did not anticipate the problems involved with getting the NECA computer connected to the Internet. That has only recently been accomplished. The committee has, subject to BOD approval, designed the web site layout and our Webmaster, Jenna Wong, will be completing the details of design and uploading the data over the next few weeks. Our target date is now March 15. 2009. We feel certain that you will find this useful tool worth the wait.
